Decision on Suspension

Dear Students,

This communication is to inform you about the decision taken by the Anti Ragging Committee regarding your suspension (Ref.No. **BITT-P/NOTICE/2025-26/11124, dated 12-11-25**). After a thorough review of your case, the Anti Ragging Committee has decided to hear you along with your parents on 28th Nov. 2025 at the given time. Please be reminded that due to the repetition of the same act (as per the notice, **Ref.No. BITT-P/NOTICE/2025-26/11124, dated 12-11-25**) and violation of rules, you are not allowed to attend the hearing without your parents. Your acts are a clear violation of the code of conduct (As per **AICTE notified Regulation for prevention and prohibition of ragging vide No. 27-3/Legal/AICTE/2009** and **UGC letter (No. F. 1-21/2009 (Anti Ragging) "In pursuance to the Judgment of the Hon'ble Supreme Court of India dated 08.05.2009 in Civil Appeal No. 887/2009, the University Grants Commission has framed "UGC Regulations on curbing the menace of ragging in higher educational institutions, 2009" which have been notified on 4th July, 2009 in the Gazette of India",)**) and create an inappropriate and disruptive environment within the college campus.
